

Fatmir (Rexhep) Isufi

(born 29/01/1970, Albanian from Çikatovë e Re/Novo Çikatovo, Gllgoc/Glogovac municipality, merchant, three children, member of KLA)

Fatmir joined the KLA after the murder of the Jashari family in Prekaz i Poshtëm/Donje Prekaze [see records]. In April 1998 he completed military training in Albania. He died on **10 November 1998** at around 16:00h, after being shot in the head during clashes between Serb forces and the KLA near the **Bajicë/Banjica** train station. His KLA fellow fighters buried him the next day in the cemetery in Bajicë/Banjica.

Abedin (Salih) Bujupi

(born 25/12/1971, Albanian from Arllate/Orlate, Gllgoc/Glogovac municipality, plumber, two children, member of KLA)

Abedin had to leave Kosovo as early as 1991, because of his activism against the Serbian regime. Three years later, he returned to Kosovo, only to leave for Germany shortly afterwards. In May 1998, Abedin returned to Arllat/Orlate and joined the KLA at their local headquarters in Llapushnik/Lapušnik. On **10 November 1998**, Abedin went in his *Ford Scorpio* from Likoc/Likovac to Negroc/Negrovce. At the intersection leading to the village of Arllate/Orlate in **Negroc/Negrovce**, he was spotted by members of Serb forces stationed near the intersection. They opened fire at his car, killing Abedin instantly. He was buried in the cemetery in Berisha/Beriša [Mališevë/Mališevo municipality].

Arton (Shaip) Haxhiu

(born 26/06/1976, Albanian from Poklek, Gllgoc/Glogovac municipality, member of KLA)

Arton joined the KLA at the beginning of 1998. He completed his training in Obri e

Epërme/Gornje Obrinje. When Serb forces attacked **Poklek** on 26 June 1998, Arton's family fled to Prishtinë/Priština, while Arton stayed behind in the village with his KLA comrades. His father and sister visited him on 27 November 1998 and they had dinner together. After dinner, Arton went to his position. On the morning of **28 November 1998**, Arton was shot by a sniper at his position. His comrades rushed him to the KLA infirmary in Gradicë/Gradica, and then to an outpatient clinic in the *Vranjevc/Vranjevac* neighbourhood in Prishtinë/Priština, where he died shortly afterwards. Later that afternoon, Arton was buried by his family members in the cemetery in Poklek.

Xhafer (Liman) Qorri

(born 18/01/1947, Albanian from Gllgoc/Glogovac, five children, member of MUP RS)

Nazif (Sahit) Mulaj

(born 5/05/1956, Albanian from Tërstenik/Trstenik, worker at the Elektroprivreda Public 41Power Company, four children)

Brahim (Isuf) Musliu

(born 17/01/1958, Albanian from Shterubullovë/Štrbulovo, Gllgoc/Glogovac municipality, worker at the *Elektroprivreda* Public Power Company, five children)

Xhafer Qorri joined the police in 1968. He was married to a Serb and had five children with her. He lived in **Gllgoc/Glogovac**, in the *Qorri* neighbourhood, between the police station and the *Feronikl* factory. On 11 November 1998, the KLA fired at his house from a shoulder-mounted rocket-launcher and with automatic weapons, simultaneously attacking the police station.

Nazif and Brahim worked at the main transformer station in Gllgoc/Glogovac. They were both electricians. Nazif lived with his family in the *Mulaj* neighbourhood in Tërstenik/Trstenik, and Brahim lived in Shterubullovë/Štrbulovo, just outside the town.

On the early morning of **11 December 1998**, Nazif and Brahim went to work.
