Ekrem (Ukë) Binakaj

Ekrem went missing on **31 May 1998** in **Krushec/Kruševac**, in unknown circumstances. There had been no news of his whereabouts until 11 September 1998, when police found his body in Krushec/Kruševac. A post-mortem examination performed on his body determined that he had been killed with a firearm.

Shaban (Binak) Muçaj

(born 25/04/1935, Albanian from Llukë e Epërme/Gornja Luka, Deçan/Dečani municipality, farmer, married, no children)

Shaban lived in Llukë e Epërme/Gornja Luka. One day in **June 1998**, he left for **Pejë/ Peć** to see his dentist. The following day, a cousin informed the Muçajs that Shaban was in the hospital in an unconscious state, after having been beaten up near the *Bistrica* River and the Orthodox church in Pejë/Peć. Some children had found him in the street and informed the Islamic religious authority (Vakuf) about this. He died three days later from the consequences of the beating. He was buried later that day in the cemetery in Katundi i Ri/Pašino Selo by members of the Vakuf.

Ukë (Rexhep) Thaçi

(born 1972, Albanian from Kosuriq/Kosurić, Pejë/Peć municipality, unemployed, single)

Ukë lived with his mother, brother and brother's family [Kosuriq/Kosurić]. He was killed on 2 June 1998 undercircum-

stances which remain unclear. Ukë had gone out into the yard, after which his mother and sister-in-law heard gunshots. They came out of the house and saw that Ukë had been shot in the head and heart. There were no Serb forces in the village at the time. Ukë was buried on 3 June 1998 in the cemetery in Kosuriq/Kosurić.

(born 17/01/1971, Albanian woman from Pejë/ Peć, designer, single)

Magribe lived with her parents in the *Dardania II/Brežanik II* borough of Pejë/Peć. On **17 June 1998**, at about 13:00h, she left for **Loxhë/Lođa** to join the KLA. Her family has never seen her since. Her cousin Bahar Bajri subsequently informed the Kajollis that Magribe had arrived in Loxhë/Lođa safely and put on a uniform. After the war, the Kajollis went to several KLA headquarters seeking information on Magribe, but found none. Magribe is listed on the ICRC list of missing persons under BLG-802129-01.
