Hajdin (Hamit) Vrenezi

(born 19/11/1946, Albanian from Qyshk/Ćuška, Pejë/Peć municipality, electrician, five children)

On **22 July 1998** Hajdin, in the company of Nimon Kastrati, Hajdin's wife's brother, left Qyshk/Ćuška and headed for Loxhë/Loda, in order to join the KLA. Hajdin had two hand grenades on him. On their way to Loxhë/Loda, in the *Dardania III/Brežanik III* borough of **Pejë/Peć**, they encountered Serb police. Nimon escaped, while Hajdin's subsequent fate was unknown until 24 July 1998. That day, the police informed Hajdin's wife that Hajdin's body was held in the morgue of the Pejë/Peć hospital. The Vrenezi buried Hajdin later that day in the cemetery in Zahaq/Zahać.

Zoran (Radivoje) Ćeranić

(born 7/10/1962, Serb from Pejë/Peć, three children, member of MUP RS)

Zoran served with the Pejë/Peć Police Department from 1993. He had completed secondary school of economics and a police training course. He held the rank of Sergeant. He was killed on **22 July 1998** at about 22:45h in clashes with the KLA in the *Dardania/Brežanik* borough of **Pejë/Peć**.

Bakir (Muhamet) Gjuka

(born 30/03/1967, Albanian from Pejë/Peć, car mechanic, one child, member of KLA)

Adem (Muhamet) Gjuka

(born 25/04/1971, Albanian from Pejë/Peć, machinist, single, member of KLA)

Bakir and Adem joined the KLA on 25 April 1998. They were tasked with supplying the KLA with weapons, medicines and clothing. Besides that, Bakir repaired the KLA vehicles. On **23 July 1998** at about 21:00h, Bakir and Adem left the *Karagaç/Karagać* neighbourhood [**Pejë/Peć**] by car in order to take some medicines to Shani Kasapi, from where someone else was to transport them to the KLA in Raushiq/Raušić. On their way back, at the entrance to their own neighbourhood, they were stopped by five paramilitaries who, after discovering they were Albanians, took them away. This incident was recounted to the Gjuka family by a neighbour, who saw it from his house. The next day, the mutilated bodies of Bakir and Adem were discovered in the *Fushë e Pejës/Pećko Polje (Pejë Field)* neighbourhood, near the sugar factory, on the road leading to the village of Katundi i Ri/Novo Selo. Serb police transported the bodies to the mortuary in the Pejë/Peć hospital. On 25 July 1998, Bakir and Adem were buried by their family in the Muslim cemetery in Pejë/Peć.

Dervish (Metë) Aličkaj

(born 20/07/1919, Albanian from Lubeniq/Ljubenici, Pejë/Peć municipality, farmer, four children)

Dervish had fought in the Second World War. He possessed a rifle and used to patrol his village of **Lubeniq/Ljubenici** carrying it. On **24 July 1998**, he left his home with the rifle, as usual, at about 06:00h. At about 10:00h, his family hear shots being fired. Dervish's son Halil went looking for his father.
