Nebojša (Čedomir) Cvejić

(born 16/07/1964, Serb from Prishtinë/Priština, one child, member of MUP RS)

Nebojša graduated with a degree in biology. In 1991, he became a member of the Serbian State Security Service in Prishtinë/ Priština. In 1994, he transferred to the State Security Service in Podujevë/Podujevo. He lived with his wife and parents in Prishtinë/Priština, and commuted to work in Podujevë/Podujevo on a daily basis. On 19 February 1998, at around 15:30h, he was driving back from work with a colleague. As they drove through Lupc i Poshtëm/Donje Ljupče, someone opened fire on them. Nebojša was hit in the temple and stomach and died instantly. He was buried the next day, on 20 February 1998, in the Prishtinë/Priština town cemetery.

Milić (Radivoje) Jović

(born 1/05/1947, Serb from Podujevë/Podujevo, one child, member of MUP RS)

Milić was a Bachelor of Laws. He worked as an Inspector for the State Security Service in **Podujevë/Podujevo**. He often received threats. In August 1997, he was shot and wounded by some unidentified attackers. On the morning of **21 December 1998**, at around 07:00h, he set out for work with Milijana Pantić, a municipal employee. Some one hundred meters from Milić's apartment, at the junction of Milo Popović and Vožd Karađorđe Streets across from the Medical Centre, two young men shot at them. Milić received seven bullets and died on the spot and Milijana was wounded. Milić was buried the next day in the Podujevë/Podujevo town cemetery.

Hetem (Zeqir) Selmani

(born 20/08/1949, Álbanian from Gllamnik/ Glavnik, Podujevë/Podujevo municipality, employee of the Obilić Thermal Power Plant, four children)

Salih (Zeqir) Selmani

(born 25/06/1951, Albanian from Gllamnik/ Glavnik, Podujevë/Podujevo municipality, teacher, three children)

The brothers Hetem and Salih lived in adjacent houses and shared the same yard. Salih was an Albanian Language teacher at the Primary School in Sfeqël/Svetlje.

On the morning of **24 December 1998**, Serb forces surrounded **Gllamnik/Glavnik** and started shelling this village. The KLA had taken positions in the woods overlooking the village. The civilians started fleeing amidst the shelling and shooting. Salih took his family out of the village and then returned home, staying there with his father
