### **Hysen (Zymer) Bytyqi**

(born 26/04/1949, Albanian from Dushanovë/Dušanovo, Prizren municipality, night watchman, six children)

### **Mehmet (Ali) Krasniqi**

(born 9/02/1968, Albanian from Dushanovë/Dušanovo, Prizren municipality, shop salesman, two children)

Hysen and Mehmet were neighbours and good friends. Until 1990, Hysen had worked as a police inspector in Prizren, when he was sacked from his job. He found work as a night watchman for *Landovica Komerc* in **Dushanovë/Dušanovo**, beside the main Prizren-Gjakovë/Đakovica road. Both men were members of the Albanian Police Trade Union. On the evening of **29 December 1998**, Mehmet called in to see Hysen and to keep him company. A night watchman at a nearby building saw a *Pinzgauer* vehicle draw up at around midnight outside *Landovica Komerc*. Several policemen got out and fired at the *Landovica Komerc* premises, where Hysen and Mehmet were. In the morning, their bodies were found by Hysen's son Driton, who also worked for *Landovica Komerc*. The police conducted an on-site investigation. Hysen and Mehmet were buried by their families on 31 December 1998 at the cemetery in Dushanovë/Dušanovo.
