

Miroljub, and his relatives, Mladen, Mladen's son Nebojša and Vitomir, alive; also the brothers Miodrag and Svetislav, Srećko Kostić, Saško Kostić, brother of the previously abducted Jugoslav [see record], the brothers Todori and Lazar, Živko Kostić, and Rajko Nikolić with his seventeen-year-old son Cvetko.

These men were seen for the last time at the KLA prison in **Malishevë/Mališevo**, when the KLA soldiers drove them together with the men from Ofterushë/Opteraša and other kidnapped Serbs and Roma towards Prishtinë/Prishtina. The fate of the Kostićs and Nikolićs was unknown until April 2005, when the UNMIK Office for Missing Persons handed over the mortal remains of all the missing men, except Mladen and Saško. Their bodies had been found in a disused mine in the village of Vulljakë/Volujak in Klinë/Klina municipality. The families buried their mortal remains on 14 October 2006 at the Orlovača cemetery in Belgrade. Mladen and Saško's names are still on the ICRC list of missing persons, under YUK-050091-01 and YUK-050095-02.

Tafil (Nuhi) Zyberi

(born 10/05/1962, Albanian from Drenoc/Drenovac, Rahovec/Orahovac municipality, farmer, five children, member of KLA)

Gani (Xhemë) Pacarizi

(born 15/05/1967, Albanian from Lubizhdë/Ljubizda, Malishevë/Mališevo municipality, worker, member of KLA)

Agim (Veli) Kelmendi

(born 3/01/1973, Albanian from Bellacërkë/Bela Crkva, Rahovec/Orahovac municipality, farmer, one child, member of KLA)

Before the war, Gani worked in Germany. He joined the KLA in March 1998 and occupied the post of Commander of Military Police in Drenoc/Drenovac. Agim and Tafil joined the KLA in April 1998 and fought in the battles for Rahovec/Orahovac.

When KLA control had been established over the town on 17 July 1998, Gani went on to Bellacërkë/Bela Crkva with a group of soldiers, Agim among them. There the KLA set up roadblocks to prevent the Serb police and army from Prizren and Gjakovë/Đakovica from reaching Rahovec/Orahovac. On 18 July 1998, Tafil came to help the KLA forces in Bellacërkë/Bela Crkva. All three were killed on **18 July 1998** in conflict with Serb forces. Gani died on the road between the villages of Bellacërkë/Bela Crkva and Sapniq/Sopnić, Agim at *Kodren e Melles/Melino Brdo (Mell's Hill)*, and Tafil at Ramadan Popaj's depot [**Bellacërkë/Bela Crkva**].

Agim's body remained where he fell until 11 October 1998, when his brother Bejtullah and relatives buried him at the cemetery in Bellacërkë/Bela Crkva, where he lies to this day.

Tafil's family buried him on 19 July 1998 at the cemetery in Drenoc/Drenovac. After the war, his remains were removed to the Cemetery for Fallen Combatants in Landovicë/Landovica.

Gani was buried in his own village of Lubizhdë/Ljubizda on the day that he died. After the war, his mortal remains were removed to the Cemetery for Fallen Combatants in Landovicë/Landovica [Prizren municipality].
