

warned him that he too might be sent to the same place as Hetem. Two weeks later, the KLA arrested Hetem's son and took him to the KLA prison camp in **Llapushnik/Lapušnik**. Hetem and his son were kept in prison separately until the early morning of **25 or 26 July 1998**, when Serb forces launched an onslaught against the KLA in the Llapushnik/Lapušnik area, as a result of which the KLA had to vacate the camp. At about 10:00h, two guards marched approximately 20 prisoners from the camp into the **Malet e Berishës/Berishine planine (Berisha's Mountains)** [Malishevë/Mališevo municipality]. They released some 10 prisoners in a field and then marched Hetem and the other remaining prisoners through the woods to a clearing where they lined them up and executed them. Hetem's son managed to escape. He was the last person to see Hetem. Hetem's body has not been found to date. He is registered on the ICRC list of missing persons under BLG-803897-01.

(born 15/02/1953, Albanian from Belincë/Belince, Shtime/Štimlje municipality)

On an undetermined date in June 1998, Hyzri left in his *TAM* lorry for Petrovë/Petrovo, to buy some lime from Qamil Ukë. That same day, he was arrested by the KLA and taken to the camp in **Llapushnik/Lapušnik**, where he was repeatedly beaten up by the guards. Hyzri was killed with a

group of prisoners in the **Malet e Berishës/Berishine planine (Berisha's Mountains)** [Malishevë/Mališevo municipality] on **25 or 26 July 1998**. In August 2001, Hyzri's remains were exhumed from the mass grave in the **Malet e Berishës/Berishine planine**. A post-mortem established that Hyzri was killed with a shot to the head. The ICTY sentenced Haradin Bala to 13 years in prison for murdering Hyzri Hajrizi and eight other prisoners.

(born 10/04/1953, Albanian from Carralëvë/Crnoljevo, Shtime/Štimlje municipality, farmer)

Emin was detained in the KLA-run prison camp in **Llapushnik/Lapušnik**, where he was so brutally beaten that he lost the power of speech and the sight of one eye. He was executed on **25/26 July 1998** in the **Malet e Berishës/Berishine planine (Berisha's Mountains)** [Malishevë/Mališevo municipality] at the hands of the KLA, along with eight other prisoners. His mortal remains were found in August 2001 at the execution site. International pathologists established that Emin had been killed with multiple shots to the head. He was buried on 3 June 2008 in the cemetery in Carralëvë/Crnoljevo. The ICTY sentenced Haradin Bala to 13 years in prison for murdering Emin Emini and eight other prisoners.
