Ibush (Bajram) Hamza

(born 15/07/1949, Albanian from Korroticë e Poshtme/Donja Koretica, Glllogoc/Glogovac municipality, three children)

Ibush's family had fled Korroticë e Poshtme/Donja Koretica as a result of a Serb attack on this village in June 1998, but Ibush stayed at home. His family have never seen him since. The ICTY established in the case of *Fatmir Limaj and others* that Ibush had been detained in the KLA prison camp in **Lapushnik/Lapušnik**. On **25 or 26 July 1998**, Ibush was executed along with eight other prisoners in the ***Malet e Berishës/Berishine planine (Berisha's Mountains)*** [Malishevë/Mališevo municipality]. His mortal remains were later found in the mass grave excavated at the execution site. The post-mortem examination performed on his body in September 2001 established multiple gunshot wounds. Additional forensic examinations confirmed multiple gunshot wounds in the chest and pelvis as the cause of the death of Ibush Hamza. Ibush was buried by his family on 3 May 2005 in the cemetery in Korroticë e Poshtme/Donja Koretica. The ICTY sentenced Haradin Bala to 13 years' imprisonment for murdering Ibush Hamza and eight other prisoners.

Hasan (Halim) Hoxha

(born 10/03/1946, Albanian from Miradi e Ulët/Donje Dobrevu, Fushë Kosovë/Kosovo Polje municipality, worker, six children)

Hasan had worked as a security guard at Prishtinë/Priština's *Grand* Hotel until 1990, after which he switched to selling cars and livestock. He was a sympathiser with the Democratic League of Kosovo. On 17 July 1998, Hasan went to Shalë/Sedlare [Lipjan/

Lipjan municipality] in the company of a friend and the friend's son. Two months later, the friend told Hasan's family that he and Hasan had been arrested by the KLA in Shalë/Sedlare and taken to the KLA-run prison in **Lapushnik/Lapušnik**. On **25 or 26 July 1998**, the KLA soldiers took all the prisoners to the ***Malet e Berishës/Berishine planine (Berisha's Mountains)*** [Malishevë/Mališevo municipality]. They set one group free, including Hasan's friend, after which they executed Hasan. Hasan's body was found in April 2002 near the place where he was executed, and identified from the clothing by his brother Ramadan and son Nuhi. The family buried Hasan on 7 March 2005 in the cemetery in Vragoli/Vragolija [Fushë Kosovë/Kosovo Polje municipality]. The ICTY sentenced Haradin Bala to 13 years' imprisonment for murdering Hasan Hoxha and eight other prisoners.

Safet lived with his parents in Petrovë/Petrovo. He was single. On the evening of 20 June 1998, he was taken from his home by several KLA members. His father heard them saying that the time had come for him to come with them. There was a
