

rumour in the village that Safet was taken away because he collaborated with Serbs.

Safet was detained in the KLA-run prison camp in **Llapushnik/Lapušnik**. On **25 or 26 July 1998**, he was executed by Haradin Bala and a KLA member nicknamed 'Murrizi' in the **Malet e Berishës/Berishine planine (Berisha's Mountains)** [Malishevë/Mališevo municipality], along with nine other prisoners. Safet's mortal remains were discovered in August 2001 near the place where he was executed. The Hysenaj family recovered them on 2 March 2005 and buried him two days later in the cemetery in Petrovë/Petrovo. Haradin Bala was sentenced by the ICTY to 13 years in prison for murdering Safet Hysenaj and eight other prisoners.

### **Bashkim (Islam) Rashiti**

(born 13/07/1964, Albanian from Godanc i Epërm/Gornje Godance, Shtime/Štimlje municipality, three children)

Sometime in the first week of July 1998, Bashkim's uncle Faik was visited by KLA soldier Jet Hasani, who told him that Bashkim should report to the KLA headquarters in Kroimirë/Krajmrovce [Lipjan/Lipljan municipality]. On Saturday 11 July 1998, Bashkim saw his wife Tahire off to work in Shtime/Štimlje, telling her that he would go and join the KLA. That was the last time his wife ever saw him.

After that, Bashkim was seen in the KLA prison camp in **Llapushnik/Lapušnik**. He was locked up in a pantry. He was executed

on **25 or 26 July 1998** along with nine other prisoners in the **Malet e Berishës/Berishine planine (Berisha's Mountains)** [Malishevë/Mališevo municipality]. Bashkim's mortal remains were found in September 2001 in the mass grave near the execution site, and buried by his family on 29 March 2005 in the cemetery in Godanc i Epërm/Gornje Godance. The ICTY sentenced Haradin Bala to 13 years imprisonment for murdering Bashkim Rashiti and eight other prisoners.

### **Lutfi (Ahmet) Xhemshiti**

(born 9/05/1964, Albanian from Breg i Zi/Crni Breg, Lipjan/Lipljan, forester, four children)

Lutfi lived with his wife Bahrije and their four children in Bred i Zi/Crni Breg. He worked as a forester. On the evening of 31 June 1998, a few KLA soldiers came up their house. They wanted Lutfi to hand them his rifle. He did so and they left. On 2 July 1998, at about 02:00h in the morning, the KLA members came again and ordered Lutfi to come with them for questioning. They told his family that he would be released in the morning. The family has never seen him since.

Lutfi was detained in the KLA-run prison camp in **Llapushnik/Lapušnik**, where he was severely beaten. On **25 or 26 July 1998**, he was executed along with a group of prisoners in the **Malet e Berishës/Berishine planine (Berisha's Mountains)** [Malishevë/Mališevo municipality]. His mortal remains were exhumed from the mass grave in the **Malet e Berishës/Berishine planine** in April 2001 and buried by his
